Jindalee Resources Limited (ABN 52 064 121 133) (**Jindalee** or **Company**) is convening its Annual General Meeting (**Meeting**) to be held at Level 2, 9 Havelock Street, West Perth, Western Australia on Friday 27 November 2020 at 11am (AWST).

Your proxy voting instruction must be received by 11am (AWST) on Wednesday 25 November 2020, being not less than 48 hours before the commencement of the Meeting. Any proxy voting instructions received after that time will not be valid for the Meeting.
